Extensions and Amendments for Return to Work

Without prejudice or precedent, the Parties agree to the following which will remain in effect until the 16th Collective Agreement is signed.

**Article 3.66 (a) Employee Equity Training and
Articles 10.53 (a), 43.35 (a), 50.53 (a), 58.06 (e) – Eligibility to serve on Selections Committees**

Employees whose equity training expired in the 2021/22 Academic Year shall have the expiration date of their equity training moved to July 31, 2022. These Employees shall be eligible to participate in Selection Committees until July 31, 2022.

The next equity workshop shall be held on or before July 31, 2022.
