Without prejudice or precedent, the Parties agree to the following which will remain in effect until the 16th Collective Agreement is signed.

**Article 3.66 (a) Employee Equity Training and
Articles 10.53 (a), 43.35 (a), 50.53 (a), 58.06 (e) – Eligibility to serve on Selections Committees**

Employees whose equity training expired in the 2021/22 Academic Year shall have the expiration date of their equity training moved to ~~July 31, 2022~~ September 30, 2022. These Employees shall be eligible to participate in Selection Committees until ~~July 31, 2022~~ September 30, 2022

The next equity workshop shall be held on or before ~~July 31, 2022~~ September 30, 2022.
