Memorandum of Agreement

June 7, 2022

Interdisciplinary Jarislowsky Chair in Trust and Political Leadership

On June 7, 2022, Acadia University announced it will receive \$2 million from the Jarislowsky Foundation in support of an endowed interdisciplinary Chair in Trust and Political Leadership – one of five such Chairs across the country.

According to the provisions of the agreement with the Foundation, Jarislowsky Chairs require \$4 million in funding, with \$2 million from the Jarislowsky Foundation and a matching \$2 million from the host institution. Acadia has guaranteed matching dollars from the Campaign funds, and fundraising efforts continue. Acadia has already secured \$650,000 towards the matching funds for the Chair.

Without prejudice or precedent, the Parties agree to the following:

The procedures of Article 10.21 and 10.53 shall apply. Notwithstanding the provisions of Article 10.53 (a) the Selection Committee for the Jarislowsky Chair in Trust and Political Leadership shall consist of up to seven (7) individuals:

1. The Head of the Department of Politics, who shall be Chair;
2. Two eligible members elected by the Department of Politics from within the Department of Politics;
3. Two eligible members elected from the faculty of Arts or Arts IDST programs. If there are more than two nominations, there shall be a vote within the Faculty of Arts to determine which members participate in the Selection Committee; and
4. In accordance with Article 10.21 (a), not more than two delegates appointed by the Jarislowsky Foundation may participate as voting members on the Selection Committee and participate fully in the interview and selection process.
